Al-Huda Public School, Parmohalla, Pattan, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Bla/375.

The fee structure of the School is being regulated by the Committee for the first time by this order.

The Principal has recorded statement in the file, stating therein that Annual Fee is not being charged and collected from the students from the Session 2019-20 onwards, but all expenditure related thereto are being spent from out of Tuition Fee. The School Management, as such, shall not charge and collect any further amount from the students except Tuition Fee.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the
