Sub: Fixation and Regulation of Fee of Al Hilal Educational Institute Hudri, Kishtwar.

Al Hilal Educational Institute Hudri, Kishtwar submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2018-21/Kat/16.

The tuition fee of the School has been regulated by the Committee vide order No. 334 FFC of 2018 Dt. 21.02.2018 for academic session 2017-18.

The school record shows that management is charging admission fee from students. Charging and collecting of admission fee is illegal and has been banned by statute.

Since the school is set-up by Jammu and Kashmir Yateem Foundation, a Society, the school management is free to receive voluntary donations and for same separate account shall be maintained. The amount shall be spent exclusively for benefit of students.

The annual fee of the School is being regulated by the Committee for the first time by this order.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
