Sub: Fixation and Regulation of fee of Al-Hira Public School, Faridabad, Doda.

Al-Hira Public School, Faridabad, Doda submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Doda/92.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

The School Management has maintained same Tuition Fee and Annual Fee for academic session 2018-19, 2019-20 & 2020-21.

Electricity Fund being current expense, is not component of Annual Fee but of Tuition Fee.

The School Management has requested for regulating of fee structure for classes 9th & 10th for academic session 2022-23. The matter will be considered when Government will give permission for same.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

Non-compliance will attract penal action under law.
