**Shah-I-Hamdan Institute Ramnagri, Shopian** submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. **FFRC/FF/2021/Shpn/380**.

The fee structure of the school is being regulated by the Committee for the first time by this order.

The record shows that school management has maintained same tuition fee from academic session 2018-19 to present session viz 2020-21.

School record further shows that all expenses/expenditure are being made by school management from out of tuition fee, donation received and sale of walnuts.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.




