Sub: Fixation and Regulation of Fee of Panorma Public Higher Secondary School Ward No.04, Near Police Lines, Rajouri.

Panorma Public Higher Secondary School Ward No.04, Near Police Lines, Rajouri submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2017-21/Raj/61.

The fee structure of the school is being regulated by the Committee for the first time by this order.

The school record shows that it has maintained same tuition fee for academic session 2019-20 and 2020-21. In view of FFRC order No.45 dated. 18.02.2021, the same fee structure has to be maintained by school management for academic session 2021-22. The school record also shows that in view of Government Circular No. 01 Edu of 2020 dt. 14.05.2020, it has not collected Annual Fee from students.

The school management shall maintain separate account in a scheduled bank and school record for the surplus amount upto 15% of tuition fee to be named as "development fund".

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The school management is directed not to charge any other fee from the students other than the fee approved by the Committee.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.



The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
