Subject: - Fixation, Determination and Regulation of Fee of Private Schools in UT of J&K.

Order No: 54 FFRC of 2021
Dated: 30.06.2021

Whereas the Committee for Fixation and Regulation of Fee of private Schools vide Order No.35 FFRC of 2021 dated 19-01-2021 directed all Private Schools of UT of J&K to Submit information as per the proforma available on Committees website www.jkffc.in for approval of fee structure, within 30 days.

Whereas the Committee received representations from Private School Associations and individual private Schools for granting extension in time period for submission of information citing reason that the schools are reopening after a long spell of closure due to Covid- 19 and the School managements are busy in preparations for opening of schools and having in place the SOPS.

Whereas the matter was examined and placed before the Hon'ble Chairperson for consideration.

After taking all aspects into consideration, the date for submission of files was extended up to 22nd March 2021 vide order No 46 FFRC of 2021 dated 22-02-2021.

Whereas the Private School Associations and individual schools again approached to this Committee with the request for extension of date of submission of files by a reasonable time, keeping in view the busy schedule of School managements viz; conducting of examinations etc.

The Matter was placed before the Committee in its meeting dated 18-03-2021. After consideration; the Committee authorized the Chairperson to take a decision about these representations.

Whereas the time period for submission of files by private schools was extended up to 10th of May 2021.



Whereas, the individual schools and Private school Associations again approached the Committee for extension in date of submission of files for fixation and Regulation of fee, citing the reason of lockdown in view of huge surge in covid-19 positive cases in UT Of J&K.

Whereas the matter was placed before the Hon'ble Chairperson for Consideration.

Whereas the Chairperson considered the matter and approved the request of Extension in the date of submission of files for Fixation and Regulation of Fee of Private Schools upto 30th June 2021.

Whereas the Chief Patron J and K Private (Un-AIDED) Schools Coordination Committee Srinager Prof. (Dr.) C. L Vishen and Principal Baramulla Public school Baramulla again prayed for Extension in the date of submission of Files for Fixation of Fee.

Whereas the matter was placed before the Hon'ble Chairperson for Consideration who observed as under" Sufficient time has been granted to Private Schools for Submitting documents as already directed. Earlier at the requests of Pvt. School managements time has been extended at least twice. However in the interest of justice last opportunity of one month is provided to Private School managements who have not complied with earlier orders, to submit their files by or before 31st July 2021, failing which action in accordance with law will be taken".

Now therefore, all the Private Schools of UT of J&K are directed to submit the files by or before 31-07- 2021 failing which action in accordance with law will follow.
