Peace School Nagam Chadoora, Budgam submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. **FFRC/FF/2021/Bud/386**.

The fee structure of the school is being regulated by the Committee for the first time by this order.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
