Sub: Fixation and Regulation of fee of Sarv Vidya Public School, Sananghat, Basohli, Kathua.

Sarv Vidya Public School, Sananghat, Basohli, Kathua submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Kat/41.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

The record shows that School Management has maintained the same fee structure from academic session 2018-19 to 2020-21, excepting for addition of Electricity Fund of Rs.80/- to the present Annual Fee.

Electricity Charge being current expense is not the component of Annual Fee but is that of Tuition Fee.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
