Sub: Fixation and Regulation of Fee of Naveen Shiksha Academy Narwal Bala, Jammu.

Naveen Shiksha Academy Narwal Bala, Jammu submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2021/Jmu/75A.

The tuition fee of the school has been regulated by the Committee vide order No. 338 FFC of 2018 dt. 21.02.2018 for academic session 2017-18

The annual fee of the school is being regulated by the Committee for the first time by this order.

The school record shows that school management has maintained same tuition fee for academic session 2019-20 and 2021-22. Even otherwise in terms of order No. 45 FFRC of 2021 dt. 18.02.2021, the school management was duty bound to maintain same fee structure for academic session 2021-22 as was existing in academic session 2020-21.

In view of orders of authorities the school management has not collected annual fee for current academic session. Electricity and telephone charges being current charges are not component of annual fee.

Record shows that school management is charging admission fee from the students at the time of their admission in the school.

This act of school management is illegal as charging of admission fee is barred by statute. The school management is restrained from charging admission fee. Violation of FFRC orders and statute will attract penal consequences.



The record also shows that school management in violation of FFC order No.338 of 2018 dt. 21.02.2018 has fixed its own tuition fee for academic session 2017-18.

The school management to explain within two months as to why action in accordance with law may not initiate for violation, FFRC orders.

The record also shows that school management has maintained same tuition fee for academic session 2017-18 and 2018-19.

Record also reveals that an amount of Rs.146018/- has been expended "on miscellaneous expenses". The "miscellaneous expenses" have neither been explained nor spell-out.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

The school management is directed not to charge any other fee from the students other than the fee approved by the Committee.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
