Sub: Fixation and Regulation of fee of Adarsh Vidya Niketan High School, Upper Mahanpur, Kathua.

Adarsh Vidya Niketan High School, Upper Mahanpur, Kathua submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Kat/113**.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

The School record shows that it has maintained same Tuition Fee for academic session 2019-20 and 2020-21 and in view of orders of authorities has not collected Annual Fee in academic session 2020-21.

Electricity Charges, being current expenses are not component of Annual Fee, but Tuition Fee.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:
