Sub: Fixation and Regulation of Fee of Shining Star Academy Muthi, Jammu.

Shining Star Academy Muthi, Jammu submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2021/Jmu/100.

The fee structure of the school is being regulated by the Committee for the first time by this order.

Perusal school record throws up following facts:

Smt. Rachna Goswami is the owner and appears to be Principal of the school.

The income -expenditure statement ending on 31.03.2020 shows that net profit of Rs.468679.35/- has been transferred to the capital account of owner.

An amount of Rs.54665/- has been spent on advertisement. An amount of Rs.95485/- has been spent on travelling and Rs.65421/- on miscellaneous expenses.

Setting-up an educational institution and imparting education is not a business activity but is a charity work.

Imparting education is not a profit making activity, being not a commercial activity.

The surplus income of the school has to remain in a school account and has not to go to owners coffers. The surplus amount has to be spent for the benefit of students and welfare of students.

Avoidable and unnecessary expenses/ expenditure have been made on advertisement, travelling and on an unexplained miscellaneous account head. All these expenditures have put harsh burden on parents. Such expenditures/expenses have no nexus with the object sought to be achieved.

The school management shall open an account in a schedule bank in the name of school and all the income of school must be credited in that account.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

The school management is directed not to charge any other fee from the students other than the fee approved by the Committee.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
