Cambridge Mission Higher Secondary School Dayala Chack Sallan, Kathua submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2019-21/Kat/143. The fee structure of the school has been regulated by the committee vide order No. FFC/FF/2019/Kat/143 dt. 31.07.2019 for academic session 2019-20.

School record shows that school management has not collected annual fee for academic session 2020-21, same position is obtaining till date, as due to 2nd Covid-19 wave schools are closed.

The audit report shows that school management is running school as a business unit and not as a charitable institution. Though the school is entitled to have a surplus of upto 15%, but same has to be spent for welfare of students and development of school, and has not be utilized for personal benefits.

Electricity, telephone charges are current expenses, so do not constitute component of tuition fee.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School



and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
