**Sub: Fixation and Regulation of fee of D.A.V. Krishna Play Way School, Ward No.2, Nagri Parole, Kathua.**

**D.A.V. Krishna Play Way School, Ward No.2, Nagri Parole, Kathua.** submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2017-21/Kat/28**.

The School Record shows that Tuition Fee for academic session 2017-18 is regulated by the Committee vide order No.125-FFC of 2017 dated 23.10.2017.

The School Record, however, shows that the School Management has not adhered to the prescribed fee structure, but has charged and collected Tuition Fee at a much higher rate.

The School Management having violated the orders of FFC, to show cause as to why action in accordance with law is not initiated and brought to logical conclusion. The reply be filed within two (02) months after which matter will be considered again.

School Record also shows that in the face of Committee's order No.45-FFRC of 2021 dated 18.02.2021 has hiked the Tuition Fee and Annual Fee, and has again violated the FFRC order, which warrants initiation of further action against the School Management.

The School Record also shows that though the School Management has not collected Annual Fee during the academic session 2020-21, but has made hike in Annual Fee during the academic session 2021-22, notwithstanding this fact that Committee's order No.45-FFRC of 2021 dated 18.02.2021 restrained all schools from making any such hike.



The documents produced in respect of fee structure do not coincide with the details of year-wise fee structure detailed out in Order No.125-FFC of 2017 dated 23.10.2017. The School Management shall explain same within two (02) months.

By making illegal and unauthorized hike in **fee structure**, the School Management besides violating the FFRC orders has indulged in commercialization of education and has also indulged in profiteering.

**For the above-stated reason, the Fee Structure of the School is freezed for academic session 2021-22, 2022-23 & 2023-24, which Fee Structure is notified as under:**

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

**Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting Admission Fee from the students.**

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.





**Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.**

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.


