**Sub: Fixation and Regulation of Fee of Shishu Model Academy Near CTM Colony, Kathua.**

**Shishu Model Academy Near CTM Colony, Kathua** submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. **FFRC/FF/2019-21/Kat/182**.

School record shows that school management in breach of order No.45 FFRC of 2021 dt. 18.02.2021 has made hike in fees. This illegal act of school management can't be countenanced either in fact or in law.

However, in view of orders of authorities the school management has not collected annual fee for academic session 2020-21 and same is position till date, as the school is still closed.

Electricity charges being current expenses are not component of annual fee.

The record shows that the school management in academic session 2021-22 has illegally hiked tuition fee ranging between 20-25%, which tantamounts to commercialization and profiteering in education.

Considering the entire conspectus of the case, the material available on record, the norms laid down in judgments and factors for regulation of fee laid down by statutes, the tuition fee of the school is maintained for academic session 2022-23 and 2023-24, which fee structure, is notified as under:

The school management is prohibited from making any hike in tuition for above said academic sessions, for seeking any further hike; the school management shall approach FFRC with documents.

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

The school management is directed not to charge any other fee from the students other than the fee approved by the Committee.

**Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.**

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

**Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.**

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.


