Sub: Fixation and Regulation of fee of Shishu Model High School, Sawan Chak, Ward No.14, Kathua.

Shishu Model High School, Sawan Chak, Ward No.14, Kathua submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Kat/103.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

The record shows that the School Management has made quantum jump in Tuition Fee from academic session 2020-21 to 2021-22 by making hike ranging from 12.5% to 20%. This hike has been made in the face of Committee's order No.45-FFRC of 2021 dated 18.02.2021, which prohibited schools from making any hike in Fee Structure during academic session 2021-22.

The School Management to show-cause why action in accordance with law may not be taken for violating FFRC orders. The reply be filed within two (02) months after which matter will be considered again.

The entire conspectus of the case was considered on the well-established norms fixed by statute and laid down by judgements. The hike made by the School Management has resulted in commercialization and profiteering of education.



The present fee structure (Session: 2021-22) of the School is, thus, maintained for academic session 2021-22, 2022-23 & 2023-24, which fee structure is notified as under:

The School Management is restrained from hiking any kind of fee up-till academic session 2023-24. For any hike in Fee Structure, thereafter, the School Management shall submit documents to FFRC.

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting Admission Fee from the students.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.



The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
