Sub: Fixation and Regulation of Fee of Public School English Medium Bijbehara, Anantnag.

Public School English Medium Bijbehara, Anantnag submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2021/Ang/282.

The fee structure of the school is being regulated by the Committee for the first time by this order.

The School management has submitted clarification as sought for in terms of order dated 20.05.2021. The school management has practice of adding annual fee on monthly basis to tuition fee. The tuition fee takes care of current expenses of school, whereas, annual fee is an expenditure which yields benefits to the school for many academic sessions.

The tuition fee and annual fee are accordingly regulated by this order. The annual fee is regulated on yearly basis, but school management can charge the same on monthly basis, by dividing annual fee by 12, if the students and/or their parents agree to such an arrangement.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the



subject, the Committee finds it just and proper to regulate the fee structure of the School as under:
