Sub: Fixation and Regulation of fee of May Fair International School, 13, Sec. B1, Laxmipuram, Chinore, Bantalab, Jammu.

May Fair International School, 13, Sec. B1, Laxmipuram, Chinore, Bantalab, Jammu submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2019-21/Jmu/154**.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

The school record shows that in the academic session 2019-20, the School Management has spend an amount Rs.59,063/- on Advertisement. Furthermore, Staff and Guest Welfare expenditure is Rs.2,13,262/-. The Audit Report does not show how much amount has been received on account of Tuition Fee, Annual Fee, Transport Fee etc.

Educational Institution is not a business entity but a charitable work. Huge amount has been spent on Advertisement, which is unacceptable. Similarly, huge amount has been spent on Staff and Guest Welfare.

The fees being paid by students cannot be spend ruthlessly by School Management.

The School Management has added new classes viz; 11th and 12th. The Tuition Fee and Annual Fee of these classes will be regulated after receiving detailed information and supportive material from School Management. **Till such time, the fee structure applicable to 9th and 10th will apply to 11th and 12th classes, as well.**

The record shows that School Management has maintained same Tuition Fee from academic session 2018-19 to 2020-21. For academic session 2021-22, the School Management has to maintain same fee structure in terms of order No.45-FFRC of 2021 dated 18.02.2021.



The school record also shows that in view of COVID-19 and orders of authorities, it has not collected Annual Fee for the academic session 2020-21.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

Charging and collecting of Admission Fee is prohibited by statutes. The School Management is prohibited from charging and collecting Admission Fee from the students.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.



The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.




