Sub: Fixation and Regulation of Fee of Albani Islamic School Jamia Chowk Nowgam, Srinagar.

Albani Islamic School Jamia Chowk Nowgam, Srinagar submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2021/Sgr/402.

The fee structure of the school is being regulated by the Committee for the first time by this order.

School record shows that it has made increase in tuition fee by almost 8.5% in academic session 2020-21. This increase is made in violation of order No. 01 FFC of 2019 dt. 28.01.2019, which stands withdrawn vide order No. 44 FFRC of 2021 dt. 18.02.2021. There appears to be violation of order No. 45 FFRC of 2021 dt. 18.02.2021. Record also shows that in tuition fee school management has made a hike by almost 9.4 % in academic session 2019-20.

The record also shows that school management has spend an amount of Rs.52336/-, Rs.148384/- and Rs.128202/- on advertisement in academic session 2017-18, 2018-19 and 2019-20 respectively.

Education by its very nature is charitable in character. Imparting education is not a commercial activity, but is a noble job, which has to be carried on without self aggrandizement and selflessly. It certainly affects the financial health of parents. It otherwise, leads to commercialization of education.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire



conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
