Sub: Fixation and Regulation of Fee of Iqra English Medium Public High School Sempora Zaingeer, Baramulla.

Iqra English Medium Public High School Sempora Zaingeer, Baramulla submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2021/Bla/410.

The fee structure of the school is being regulated by the Committee for the first time by this order.

School record shows that it has maintained same tuition fee from academic session 2017-18 to 2019-20 and same tuition fee is maintained for academic session 2020-21 in terms of order No. 45 FFRC of 2021 dt. 18.02.2021.

The school management has not charged and collected annual fee upto academic session 2019-20. But has made request for allowing school to charge and collect annual fee from academic session 2021-22.

Electricity and telephone charges being current expenses are components of tuition fee.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the

subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
