Sub: Fixation and Regulation of fee of Iqbal Islamia Model High School, Gantamulla Colony, Fatehgarh, Baramulla.

Iqbal Islamia Model High School, Gantamulla Colony, Fatehgarh, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Bla/419**.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

Record shows that the School Management is not charging and collecting Annual Fee from the students. The School Management has not requested for regulation of Annual Fee and accordingly has not provided any information/material for same. The School Management shall not charge and collect Annual Fee from students until orders about same are obtained from FFRC.

School Management to advert its attention for enhancing the academic standards.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.




