Sub: Fixation and Regulation of Fee of Shah-i-Hamdan Public School Zaloora Sopore, Baramulla.

Shah-i-Hamdan Public School Zaloora Sopore, Baramulla submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office FFRC/FF/2021/Bla/420.

The fee structure of the school is being regulated by the Committee for the first time by this order.

Record shows that the school management has maintained same tuition fee for academic session 2018-19 and academic session 2019-20. In terms of order No. 45 FFRC of 2021 Dt. 18.02.2021 same tuition fee is maintained by this FFRC order for academic session 2020-21.

The school management has not provided documents/information about tuition fee from Nursery to UKG classes. The annual fee is also accordingly regulated.

The school management shall not charge and collect any annual fee for classes other than regulated by this order, until such time orders for same are obtained from FFRC.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the



School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

Non-compliance will attract penal action under law.
