Sub: Fixation and Regulation of fee of Islamia Model High School, Fatehgarh, Baramulla.

Islamia Model High School, Fatehgarh, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Bla/417**.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

Record shows that the School Management has spent an amount of Rs.50,000/- on Newspaper. It is certainly surprising that a village school is spending such huge amount, whereas schools in cities are not spending such huge amount on this activity. School Management to submit details of Newspapers purchased for academic session 2019-20 and Receipts and Payments.

The School Management has maintained same Tuition Fee for academic session 2017-18, 2018-19, 2019-20 and 2020-21.

The School Management shall submit detailed break-up report about Annual Fee, and till same is done, shall not charge and collect any amount on account of Annual Fee from students.

The School Management shall take immediate steps for improving academic standards.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the



School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

Charging and collecting of Admission Fee is prohibited by statutes. The School Management is prohibited from charging and collecting Admission Fee from the students.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.




