**Sub: Fixation and Regulation of fee of Hanfia Model Middle School, Lalpora, Kunzer, Tangmarg, Baramulla.**

**Hanfia Model Middle School, Lalpora, Kunzer, Tangmarg, Baramulla** submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Bla/409**.

The Committee, vide Order No.655 – FFC of 2018 dated 09.10.2018, has fixed Tuition Fee of the School for the **Session 2017-18**.

School record shows that it has not charged and collected Annual Fee for session 2019-20 & 2020-21. The School Management has not requested for regulation of Annual Fee and accordingly has not provided any information/material for same. The School Management shall not charge and collect Annual Fee from students until orders about same are obtained from FFRC.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:
