Sub: Fixation and Regulation of fee of Raazi Memorial Public School, Krankshivan Khoie, Sopore, Baramulla.

Raazi Memorial Public School, Krankshivan Khoie, Sopore, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Bla/407.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

Record shows that the School Management has charged and collected Admission Fee in the academic session 2019-20. Charging and collecting of Admission Fee is illegal and is barred by statutes. The School Management is prohibited from charging and collecting Admission Fee from the students.

School record shows that the School Management has not charged and collected Annual Fee during the academic session 2020-21.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:
