Sub: Fixation and Regulation of fee of New Bonvivant English School, Bul Bul Lanker, New Campus, Mullapora, Aali Masjid, Eidgah, Hawal Road, Srinagar.

New Bonvivant English School, Bul Bul Lanker, New Campus, Mullapora, Aali Masjid, Eidgah, Hawal Road, Srinagar submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Sgr/433.

This School also figures in the list appended to order No.02-FFC of 2019 dated 04.02.2019.

School record shows that fee structure has not been regulated legally in accordance with statutes and precedential norms. The fee structure of the School is accordingly regulated for the first time by this order.

School record also shows that School Management has spend an amount of Rs.65,185/- in academic session 2019-20 on Advertisement. Educational Institutions are not business units. Educational Institutions are set-up to convert raw children into good human beings, who when leave institutions act as fulcrum of a healthy society. Spending huge amounts on Advertisement is unacceptable.

The record also shows that School Management has while promoting child from 3rd to 4th Primary brought up the fee @ Rs.800/- also, which child was paying in Class 3rd, whereas, Class 4th child has been paying monthly Tuition Fee in Class 4th @ Rs.750/- in academic session 2018-19, 2019-20. Same is the position with the child who has been promoted from 5th to 6th Class.

Fixing of Tuition Fee by School Management does not stand to reason. This appears to be a novel and innovative mode of hiking fee resulting in commercialization and profiteering of education. The School Management shall stop this practice in forthwith.

Record also shows that School Management does not charge and collect Annual Fee from students of Nursery to UKG.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

Charging and collecting of Admission Fee is prohibited by statutes. The School Management is prohibited from charging and collecting Admission Fee from the students.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
