Sub: Fixation and Regulation of Fee of Shri Narsingh Vidya Peeth Higher Secondary School Naran Ghagwal, Samba.

Shri Narsingh Vidya Peeth Higher Secondary School Naran Ghagwal, Samba submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2021/Samba/81.

The fee structure of the school is being regulated by the committee for the first time by this order.

School record shows that the annual fee which the school charged in academic session 2019-20 ranged from Rs.1500/- to Rs.3000/-. Class 1<sup>st</sup> to 3<sup>rd</sup> was charged Rs.1500/-, class 4<sup>th</sup> and 5<sup>th</sup>, Rs.1600/-, class 6<sup>th</sup> Rs.1700/-, class 7<sup>th</sup>, Rs.Rs.1800/- class 8<sup>th</sup>, Rs.2200/-, class 9<sup>th</sup>, Rs.2500 /- and class 10<sup>th</sup>, Rs.3000/-. In yet another document giving break-up of annual fee for academic session 2019-20 and 2020-21 increased annual fee is shown for all the classes excepting 1<sup>st</sup> and 10<sup>th</sup>. Another document marked as 'A' and subsequent document marked as 'B' providing different annual fee needs an explanation from school management. Explanation shall reach this office within two months.

The school record shows (A and B) that school management is charging an amount ranging between Rs.165/- to Rs.300/-as news paper fund, whereas, the audit report ending 31.03.2020 shows an expenditure of Rs.3520/- on newspaper. The school management is thus hoodwinking the children and their parents. The school management to explain its position within two months.

In view of the above circumstances annual fee is regulated to ensure that there is no commercializing and profiteering of education.

The record also shows that school management has provided details of tuition fee for academic session 2019-20 in two separate documents, which do not reconcile with each other. This aspect also needs to be explained by school management within two months.

While regulating fee structure, the above enumerated circumstances are also taken note of.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

The school management is directed not to charge any other fee from the students other than the fee approved by the Committee.

Charging and collecting of Admission Fee is prohibited by statutes.

The school management is prohibited from charging and collecting admission fee from the students.

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
