**Sub: Fixation and Regulation of fee of Public Model School Hail Saloosa Wagoora Baramulla.**

Public Model School Hail Saloosa Wagoora Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Bla/447.

The Committee vide Order No.640-FFC of 2018 dated 09.10.2018 has approved the tuition fee of the School for the **Session 2017-18**.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

Non-compliance will attract penal action under law.


