## Office of the Chairperson Committee for Fixation & Regulation of Fee of Private Schools, J&K (FFRC)

Order No: 355-FFRC (FF) of 2021 Dated: 16 -07-2021

Sub: Fixation and Regulation of fee of Lawrence Public School, Darbargarh Road, Panjtirthi, Jammu.

Lawrence Public School, Darbargarh Road, Panjtirthi, Jammu submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2019-21/Jmu/169.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

School record shows that in pursuance to orders of authorities School Management has not charged and collected Annual Fee in academic session 2020-21 and has maintained same Tuition Fee for academic session 2019-20 & 2020-21, whereas, same Annual Fee has been maintained from academic session 2018-19. In terms of Order No.45-FFRC of 2021 dated 18.02.2021, the fee structure during academic session 2021-22 has not to be increased.

Record shows that Picnic/Excursion Fee @ Rs.600/- is being charged as component of Annual Fee. Picnic activity is not compulsory but optional. A student may or may not join the Picnic/Excursion activity. It is voluntary in nature. Picnic/Excursion Fee can be collected only during the period such activity is decided to be undertaken, and has to be collected only from those students who opt for it and not from all students. Fixed amount of Rs.600/- on account of Picnic Charges cannot be collected from students. Amount of Picnic Charges to be paid, will depend on the destination of Picnic. This amount is accordingly deducted from Annual Fee, being not its component.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
