**Sub: Fixation and Regulation of Fee of Iqra Islamia Institute
Hangalbuch Yaripora, Kulgam.**

Iqra Islamia Institute Hangalbuch Yaripora, Kulgam submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. **FFRC/FF/2021/Kul/455**.

The fee structure of the school is being regulated by the Committee for the first time by this order.

The School management shall provide detailed information with documentary support about charging and collection of annual fee. Till such time information is provided the annual fee as was being collected in academic session 2019-20 shall be collected subject to its actual utilization.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.

The school management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
