Budding Bloom Experimental School Near Govt. Degree College (Boys) Khawaja Bagh, Baramulla submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2021/Bla/453.

Record shows that in law fee structure of school has not regulated, and is being regulated by the Committee for the first time by this order.

School record shows that school management has not collected annual fee for academic session 2019-20 to 2020-21.

Record also shows that school claims being from Nursery to 10<sup>th</sup>, but no information has been provided about fee structure of Nursery to U.K.G.

School management to provide information about fee structure of classes Nursery to U.K.G within week's time. Until further orders from FFRC the fee charged in academic session 2019-20 may be collected subject to all just exceptions.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:
