Satya Model High School Billawar, Kathua submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2021/Kat/128.

The fee structure of the school is being regulated by the committee for the first time by this order.

Record shows school management has maintained same tuition fee for academic session 2019-20 and 2020-21. In view of order No. 45 FFRC of 2021 dt. 18.02.2021, same fee structure is to be maintained by school management in academic session 2021-22. School has surplus of 13% in academic session and financial year 2019-20.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.



The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
