Sant Bal Yogeshwar Bhartiya Vidya Mandir, Dadwara, Phinter, Billawar, Kathua submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2019-21/Kat/39.

The Committee vide No.FFC/FF/2019/Kat/39 dated 09.07.2019 has approved the fee structure of the School for the Session 2019-20.

Record shows that School Management has maintained same fee structure for academic session 2019-20 and 2020-21.

Record also shows that School Management has spent an amount of Rs.82,157/- and Rs.84,272/- on Advertisement in academic session 2018-19 and 2019-20 respectively.

The Educational Institution is not a business unit. Education is charity. Spending huge amounts on Advertisement is unacceptable. This amount is being borne by parents of students. School Management shall refrain from indulging in such a luxury.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:
