Sub: Fixation and Regulation of Fee of Modern Public School Rakh Amb Tali, Samba.

Modern Public School Rakh Amb Tali, Samba submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2021/Samba/117.

The tuition fee of the school has been regulated by the committee vide order No. 649 FFC of 2018 Dt. 09/10/2018 for academic session 2018-19.

The annual fee of the school is being regulated by the committee for the first time by this order.

School record shows that management has not collected annual fee in academic session 2020-21.

School record also shows that school has spend an amount of Rs.34800/- on advertisement in academic session 2019-20. An amount of Rs.40930/- is spent as "Miscellaneous Expenses" without spelling out the amount spent for what purpose. Furthermore, an amount of Rs.560980/-, have been received as promotion charges. But in the "Payment side" of payment and receipt account for the year ending 31.03.2020 no corresponding payment is made. The expression "promotion charges", otherwise, is vague.

Similarly in previous two academic years amount of Rs.15000/- and Rs.19400/- have been spent on advertising.

For the sake of repetition it is again stated that educational institutions are not commercial establishments.

These institutions work on no gain basis. The school management shall refrain in future in making avoidable and unnecessary expenditures, which in



turn burn hole in the pockets of parents and result in commercialization of education.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and' acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

The school management is directed not to charge any other fee from the students other than the fee approved by the Committee.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
