**Order No: 306-A-FFRC (FF) of 2021
Dated: 20-08-2021**

Sub: Fixation and Regulation of fee of Islamia Model High School, Fatehgarh, Baramulla.

Islamia Model High School, Fatehgarh, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Bla/417**.

In view of the Para – 5 of Order No.306-FFRC (FF) of 2021 dated 09.07.2021, which is taken note of:


“The School Management shall submit detailed break-up report about Annual Fee, and till same is done, shall not charge and collect any amount on account of Annual Fee from students.”,

the Annual Fee of the School is being regulated by the Committee for the first time by this order.

In pursuance to Order No.306-FFRC (FF) of 2021 dated 09.07.2021, Headmaster of School has submitted detailed break-up of Annual Fee. At Serial No.5 of the report appears Admission Fee, which is settled as Rs.500/-.

Headmaster to explain for what purpose this amount of Rs.500/- is being charged, as charging of Admission Fee is barred by statute. Information be provided within one (01) week.

The School Management in pursuance to Order No.306-FFRC (FF) of 2021 dated 09.07.2021, was directed provide detailed break-up of Annual Fee. Vide its



document dated 18.08.2021, detailed break-up was provided by School Management. However, the School Management vide even dated order was asked for what purpose an amount of Rs.500/- is being charged, that too as Admission Fee. The Headmaster vide document dated 20.08.2021 has certified that School Management is not charging Admission Fee, but had made a proposal for allowing them to charge the same at the rate of Rs.500/-.

The whole issue is considered in accordance with settled norms, and by this order, Annual Fee of the School is regulated as under:

Annual Fee: Session 2020-21

Nursery to 5 th	Rs.550/-
6 th to 10 th	Rs.750/-

Annual Fee: Session 2021-22


Nursery to 5 th	Rs.700/-
6 th to 10 th	Rs.900/-

Annual Fee: Session 2022-23

Nursery to 5 th	Rs.900/-
6 th to 10 th	Rs.1100/-

The aforesaid exercise has been undertaken and Annual Fee regulated in a manner that excluded the commercialization and profiteering of education completely.

Charging and collecting of Admission Fee is prohibited by statutes. The School Management is prohibited from charging and collecting Admission Fee from the students.



The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.

This order shall constitute and form part of Order No.306-FFRC (FF) of 2021 dated 09.07.2021 and shall be placed on said file.


