Sub: Fixation and Regulation of Fee of Hanfia Noorani Public School Khull Noorabad, Kulgam.

Hanfia Noorani Public School Khull Noorabad, Kulgam submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2021/Kul/474.

The fee structure of the school is being regulated by the committee for the first time by this order.

The school record shows that unreasonable hike has been made in tuition fee in successive academic sessions.

Record also shows that in audit report ended 31.03.2020 an amount of Rs.132220/- has been expended under head "educational fund". Previous two years ended on 31.03.2018 and 31.03.2019 no such fund exists. Besides "education fund" is not spelt out.

Despite making unjustifiable expenses/expenditure the school has surplus amount.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The school management is directed not to charge any other fee from the students other than the fee approved by the Committee.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.



Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
