**Sub: Fixation and Regulation of fee of National Public High School, Draba, Surankote, Buffliaz, Poonch.**

National Public High School, Draba, Surankote, Buffliaz, Poonch submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Poonch/476**.


The **fee structure** of the School is being regulated by the Committee for the first time by this order.

The Principal has certified that for last two years due to COVID-19 there have been no extracurricular activities in the School. Despite this factual declaration by Principal in the Audit Report ended 31.03.2020 and 31.03.2021, an amount of Rs.53,660/- and Rs.51,455/- respectively have been shown to have been spent as "Function Expenses". Besides this, an amount of Rs.54,671/- and Rs.1,27,785/- have been purportedly spend under head "Miscellaneous Expenses", without spelling out what these expenses have been and how the expenditure has been made.

The School has had surplus amount in each succeeding academic year.

Appallingly the surplus amount is being credited into the account of owner of School.

The School Management shall open an account in a schedule bank in the name of School and all incomes must be deposited in the said account, including the surplus amount, which shall be spent on welfare of children and development of School. The account shall be operated by person(s) authorized by School Management.



The records seem to be manipulated to some extent. Principal and Chairperson to explain within two (02) months the anomalies appearing in record, more particularly, record dealing with finances of School.

The school record shows that Annual Fee has not been collected due to COVID-19 pandemic.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

**Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting Admission Fee from the students.**

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

**Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.**

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.




