Sub: Fixation and Regulation of fee of Montessory Public School, Ward No.4, Reasi.

Montessory Public School, Ward No.4, Reasi submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Reasi/93.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

School record shows that an amount of Rs.1,000/- is being charged and collected from students on account of "School Charges". Furthermore, an amount of Rs.1,000/- is being charged and collected from students on account of "Establishment Charges". It prima facie appears that these vague and unexplained terms have been used to earn money. An amount of Rs.1,000/-, is accordingly, deleted from "Annual Fee".

Children at the level of Nursery to UKG are also being charged Rs.1,000/- as Martial Arts fee, an incomprehensible act of School Management.

In addition to monthly Tuition Fee, Computer Fee and Smart Class Fee are being charged and collected separately from the students. Such an exercise undertaken by School Management is unacceptable.



The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting Admission Fee from the students.

The School Management shall maintain an account of School Funds (Fee etc.) in a Schedule Bank, which shall be operated by a person(s) authorized by School Management. Record about all the expenses/expenditures shall be maintained with receipts.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.



Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
