St. John's Convent School, Phallian Mandal, Satwari, Jammu submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2018-21/Jmu/149.

The Committee vide Order No.376-FFC of 2018 dated 24.04.2018 has fixed the Tuition Fee of the School.

School record shows that School has been charging an amount of Rs.1000/from students of each class on account of Water and Electricity Charges. Water and
Electricity Charge is a current expense and not annual expenditure, thus cannot
constitute component of Annual Fee and is accordingly deleted from same. Record
shows that School Management has retained substantial amount as surplus.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting Admission Fee from the students.

The School Management shall maintain an account of School Funds (Fee etc.) in a Schedule Bank, which shall be operated by a person(s) authorized by School Management. Record about all the expenses/expenditures shall be maintained with receipts.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
