Sub: Fixation and Regulation of fee of Shishu Niketan Academy Chak Haria Zone Marheem Kathua.

Shishu Niketan Academy Chak Haria Zone Marheem Kathua submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Kath/137.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

School record shows that the school management has maintained same fee structure from nursery to 8<sup>th</sup> to which level it was initially operating from academic session 2014-2015 to academic session 2020-21. For the 9<sup>th</sup> 10<sup>th</sup> classes same fee has been maintained ever-since these classes were started.

Record shows that in academic session 2019-20 school has surplus of 27.4%. Record further shows that teaching and non teaching staff is not being paid appropriate salary which must be affecting the educational standards of school.

The school management shall take steps to increase the salary of its employees and pay them proper salary.

The surplus of 27.4% is an indication that school management is leading towards commercialization of education.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:
