Shiva Modern Academy Poonda Zone- Mahanpur Kathua submitted file for fixation and regulation of fee structure of the School, which has been registered in EERC office under No. FFRC/FF/2021/Kat/131.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

The School record shows that in the academic session 2019-20 it has surplus of about 28%, this surplus amount is to be spend on the better education of children. The 28%, of surplus indicates that school is heading towards commercialization of education. The present fee structure of the school is maintained till academic session 2022-23, however, for academic session 2023-24 reasonable hike is allowed in Fee Structure.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

The School Management shall maintain an account of School Funds (Fee etc.) in a Schedule Bank, which shall be operated by a person(s) authorized by School Management. Record about all the expenses/expenditures shall be maintained with receipts.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
