Order No: 42/-A -FFRC (FF) of 2021 Dated: 31 -08-2021

Sub: Fixation and Regulation of fee of Iqra English Medium Public School, Takia Behram Shah, Anantnag.

In terms of order No.421-FFRC (FF) of 2021 dated 11.08.2021, fee structure of Iqra English Medium Public School, Takia Behram Shah, Anantnag, was regulated.

Since the School Management had not provided any information/documents from Pre-Nursery to UKG classes, as such, fee of these classes could not be regulated on the presumption that the School has classes starting from 1<sup>st</sup>.

Today, the Principal of the School submitted application in which he has stated that due to mistake of the School, information/documents about classes from Pre-Nursery to UKG was not provided to FFRC earlier. It is further stated in application that fee structure of Pre-Nursery to UKG alongwith other classes was published in Daily Newspaper. Copy of the relevant page of the newspaper is also enclosed with the application. It is further stated in the application that fee structure of these classes, viz; Pre-Nursery to UKG was also approved by FFC vide order No.86-FFC of 2017 dated 06.06.2017.

In the aforesaid circumstances, the fee structure of the classes starting from Pre-Nursery to UKG, on the basis of well-settled norms and after examining the records is regulated as under:

Session: 2020-21 & 2021-22

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting Admission Fee from the students.

The School Management shall maintain an account of School Funds (Fee etc.) in a Schedule Bank, which shall be operated by a person(s) authorized by School Management. Record about all the expenses/expenditures shall be maintained with receipts.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
