Sindh Valley Educational Institute, Kangan, Ganderbal submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Gbl/501.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

The School record shows that School Management has maintained same Tuition Fee from academic session 2016-17 to academic session 2020-21.

Record shows that School Management has been charging Admission Fee. School Management is restrained from charging Admission Fee in view of court order and prohibition thereof contained in Jammu and Kashmir School Education Act' 2002 and Right to Free and Compulsory Education Act' 2009.

Record also shows that School Management is not charging Annual Fee.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the
