Sub: Fixation and Regulation of Fee of Islamic Revival International School Kangan, Ganderbal.

Islamic Revival International School Kangan, Ganderbal submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. FFRC/FF/2021/Gbl/559.

The fee structure of the school is being regulated by the committee for the first time by this order.

A peep in the school record gives out certain details which are taken note of:.

The school record also shows that school management has maintained same tuition fee for academic session 2019-20 and 2020-21, as is, otherwise, mandate of order No. 45 FFRC of 2021 dt. 18.02.2021.

Record further shows that school management has not charged and collected annual fee for academic session 2019-20 and 2020-21.

The audit report shows that school has maintained surplus and more particularly in the year ended 31.03.2020, the school has surplus of 17.50%.

The surplus amount has to be spend on the benefit of students and for their welfare.

The land purchased from school funds and constructions made from school funds, which come from the coffers of parents, whose wards are studying in the school, make it imperative on the school management to keep these properties in the name of school, as they are owned by school. These properties cannot be kept in the name of any person or persons, other than the school.

School record also shows that school management is charging and collecting picnic and excursion fee as a component of annual fee. Picnic/excursion charges are not component of annual fee, but is a voluntary and optional fee, depending on the students availing, or not availing the picnic/excursion facility. This item is accordingly deleted from annual fee.

Since the school management has had surplus of 17.50% in year ended 31.03.2020, the school management is heading rather, entered into commercialization stage of education. This tendency and activity of the school management has to be nipped in the bud.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and prescribed by statute. On due consideration of the entire conspectus of the school record and' acknowledged parameters and settled norms for regulating the fee structure of the school, material produced

by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

Charging and collecting of Admission Fee is prohibited by statutes.

The school management is prohibited from charging and collecting admission fee from the students.

The school management shall maintain an account of school funds (fee etc) in a Schedule Bank, which shall be operated by a person(s) authorized by school management. Record about all the expenses/expenditures shall be maintained with receipts.

The school management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
