Shaheen Public School Ganderpora Eidgah, Srinagar submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. **FFRC/FF/2021/Sgr/565**.


Record shows that fee structure of school has not been regulated in accordance with law uptill now.

The tuition fee school of school is being regulated in accordance with law, for the first time by this order.

Since no details and breakup is given about charging and collection of annual fee, the school management shall not charge and collect the from students until such time, record is submitted and orders obtained from the FFRC.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and prescribed by statute. On due consideration of the entire conspectus of the school record and' acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of

the School as under:

Non-compliance will attract penal action under law.


