School management is directed not to charge and collect annual fee from students till the required documents and supportive material is submitted to FFRC and orders thereon are passed by authority.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and prescribed by statute. On due consideration of the entire conspectus of the school record and' acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of

the School as under:

Non-compliance will attract penal action under law.
