**Sub: Fixation and Regulation of Fee of Little Angel Academy High School, Kishtwar.**

**Little Angel Academy High School, Kishtwar** submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. **FFRC/FF/2021/Kisht/216**.

The fee structure of the school is being regulated by the Committee for the first time by this order.

Record shows that school management has maintained same tuition fee from academic session 2019-20 to 2020-21 and will maintain same tuition fee for academic session 2021-22.

Record also shows that school management has surplus of about 26% in the year ended 31.03.2020. This surplus is to be spent for welfare and benefit of students.

School management has not provided details about charging of annual fee. If school management has any claim about annual fee, then same may be projected with detailed breakup. Until such time annual fee shall not be charged and collected from students,

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and prescribed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the



subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law
