Order No: 50 / -FFRC (FF) of 2021 Dated: 23 -08-2021

Sub: Fixation and Regulation of fee of New Model Academy, Shah, Vijaypur, Sarna, Samba.

New Model Academy, Shah, Vijaypur, Sarna, Samba submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Samba/62.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

While examining the School record, it was noticed that in Annual Fee, 'Promotion Charges' is shown as a component thereof. Notice was issued to School Management to clarify the position. Orders dated 20.07.2021 and 09.08.2021 are taken note of:

"20.07.2021 School record shows that School Management has been charging Admission Fee and 'Promotion Charges' as components of Annual Fee. Charging and collection of Admission Fee is barred by statute.

The School Management to clarify and explain within ten days what the 'Promotion Charges' stand for. 'Promotion Charge' is something novel which is not component of Annual Fee. In case clarification sought for is not given within stipulated time, the 'Promotion Charges' will be excluded and orders about fee regulation passed.

<u>09.08.2021</u> The School response is incomplete and inadequate. 'Promotion Charges' have to be explained. For what purpose 'Promotion Charges' are levied and what purpose it serves.

In the interest of justice last opportunity of one week is given to Principal/Chairperson to provide the requisite information. It is made clear



that in case information sought for is not provided within stipulated time, 'Promotion Charges' will be excluded from Annual Fee and fee structure regulated."

Explanation/Clarification as sought for above is not provided by School Management.

Child/Student by his hard-work gets promoted from one class to another class.

Charging of money as 'Promotion Charges' would mean that a child is getting promoted to higher class not on his merit, but by paying money. Educational Institutions do not promote children on money, but on merit. 'Promotion Charges' are anti-thesis to concept of Education and Educational Institutions. 'Promotion Charges' are greek to Education.

In view of above, the 'Promotion Charges' stand deleted from Annual Fee.

Record also shows that School Management has not received Tuition Fee and Annual Fee during academic session 2020-21.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and prescribed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting Admission Fee from the students.

The School Management shall maintain an account of School Funds (Fee etc.) in a Schedule Bank, which shall be operated by a person(s) authorized by School Management. Record about all the expenses/expenditures shall be maintained with receipts.



The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
