Sub: Fixation and Regulation of fee of Syed Kamal-ud-Din Bukhari (SKB) Public School, Naidkhai, Sonawari, Hajin, Bandipora.

Syed Kamal-ud-Din Bukhari (SKB) Public School, Naidkhai, Sonawari, Hajin, Bandipora submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Bpr/472.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

School record shows that School Management has maintained same fee structure from academic session 2018-19 to 2020-21.

The Audit Report ended 31.03.2019 shows that School Management has expended an amount of Rs.3,18,380/- on Travelling and Conveyance; Rs.1,09,168/- as Miscellaneous Expenses. Similarly, Audit Report ended 31.03.2020 shows that an amount of Rs.82,560/- has been spent on Travelling and Conveyance; Rs.2,65,000/- has been advanced as loan; Rs.1,25,000/- expended as Miscellaneous Expenses.

Travelling and Conveyance and Miscellaneous Expenses are neither explained nor spelt out. The School Management could not provide loan from School Corpus to anyone. The School Fund is to be spent on welfare of students and development of school.



It prima facie appears that irregularities have been committed. Principal and Chairperson of School to explain the position within two (02) months.

The School Management shall maintain an account of School Funds (Fee etc.) in a Schedule Bank, which shall be operated by a person(s) authorized by Management. Record about all the expenses/expenditures shall be maintained with receipts. The School has surplus amount in its coffers.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
