**Sub: Fixation and Regulation of fee of Iqra English Medium Public School,

Communication vide Ref. No. IPS/368/21 dated 01.09.2021 of Principal is taken note of:

“With great regards and honour, I, principal Iqra English Medium public School Takia Behram Shah, first of all, want to thank your good and kind self for urgently acting on the request of fixing fee from classes Pre Nursery to U.K.G as we had forgotten to mention the same in our file submitted in FFRC Office under No.FFRC/FF/2021/Ang/517. The Committee vide order No.421-FFRC (FF) of 2021 dated 11.08.2021 and 421 (A) – FFRC (FF) of 2021 dated 31.08.2021 now approved the tuition fee from class 1<sup>st</sup> to 10<sup>th</sup> and Pre-Nursery to U.K.G. But now I again feel ashamed as we had again forgotten to mention the annual charges from classes pre-nursery to U.K.G being taken by the school from past few sessions copy of same along with the copy of a fee receipts is attached with the letter and the same was taken as per your orders issued vide order no 86-FFC of 2017 dated 06.06.2017 copy of which is attached with the letter, but it is being fixed by your good self as just Rs.30/-, but sir we usually take printing charges, magazine charges, admission form charges, red cross and games fund charges and other charges with the annual fee and your good self is aware that day by day these charges are increasing at an alarming rate and it will be difficult for the school to bear these charges as our school is a non-profit organization, which is being run by the community. I once again beg your kind and good self to accept my apology and forgive me for my stupid mistakes and for wasting your precious time daily. Keeping in view our previous record of annual charges kindly fix the



same accordingly, that will be your most kindness and your good self will always be remembered in prayers.”

In view of above situation, it becomes duty of Committee to keep the record straight.

Thus, the Annual Fee of the classes starting from Pre-Nursery to UKG, on the basis of well-settled norms and after examining the fresh records now submitted by Principal, is regulated as under:
