Order No: <u>432-A</u>-FFRC (FF) of 2021 Dated: <u>06</u>-09-2021

Sub: Fixation and Regulation of fee of Famous Abhay Mission Secondary School, Dachigam Road, New Theed, Harwan, Srinagar.

In terms of Order No.432-FFRC (FF) of 2021 dated 16.08.2021, the School Management has submitted its response vide communication dated 1<sup>st</sup> of September' 2021. The Principal has stated that all the directions issued by the Committee have been implemented and the partnership deed has been dissolved. Copy of the dissolution of partnership deed has also been enclosed with the communication.

Deed of dissolution of partnership shows that parties have decided to dissolve the partnership deed and constitute a Trust for running the said School in compliance to Order No.432-FFRC (FF) of 2021 dated 16.08.2021.

Since the partners have resolved to dissolve partnership deed and infact copy of the deed of dissolution of partnership has also been placed on record and it has been undertaken that for running school, a Trust will be constituted, in modification of the Order No.432-FFRC (FF) of 2021 dated 16.08.2021, it is provided as under:

- A. The School shall be deemed to function as a Public Trust.
- B. The Education of the students of the School must continue as usual.
- C. The Chairperson of the School shall open an account in the name of the School in a Scheduled Bank which shall be operated upon by Chairperson and Principal of the School jointly.

The Principal and the Chairperson of the School shall be responsible to maintain all accounts and shall further ensure that School Funds are spent for improvement of School and for imparting proper education to the students.



The Chairperson and Principal shall submit compliance report about the aforesaid directions within two (02) weeks.

Record shows that School Management has not charged and collected Annual Fee for academic session 2020-21.

Record also shows that School Management has maintained same Annual Fee for academic session 2018-19, 2019-20 and 2020-21 and as already stated has not collected Annual Fee for academic session 2020-21.

School record shows that School has surplus, though meagre, which has to be utilized for the benefit of students.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and prescribed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting Admission Fee from the students.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.



The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.

This order shall form part of Order No.432-FFRC (FF) of 2021 dated 16.08.2021 and be made part of same record.
